




FOREIGN-BORN POPULATION IN JAPAN

- The Share of the foreign-born population in Japan is one of the lowest in the OECD country.
- The total number of foreign born-residents in Japan is approximately 2.93 million, whereas the U.S. recorded about 44.8 million.




Note: Data refer to 2000 or the closest available year, and to 2018 or the most recent available year. The OECD and EU/EFTA averages are simple averages based on rates presented. For Japan and Korea, the data refer to the foreign population rather than the foreign-born population.


FOREIGN POPULATION IN JAPAN 1950-2005





INVISIBLE DIFFERENCE (BLOOD) AS A RACIAL SIGNIFIER

- Susie Phipps Case
- Until her 40s, Susie Guillory Phipps lived her life as white. In 1977, when she obtained her birth certificate to get a passport, she realized that she has been classified as Black, because of her state (Louisiana) law which declared anyone with at least 1/32 or more of "Negro Blood" to be designated as black.
- Susie Guillory Phipps had 3/32 Negro blood her great-great-great grandmother was an enslaved African woman by the name of Marguerite.

"My children are white. My grandchildren are white. Mother and Daddy were buried white. My Social Security card says I'm white. My driver's license says I'm white. There are no blacks out where I live, except the hired hands. My birth certificate is the only thing that says I'm black."
