

## LSA Student Government Special Election 2020 Director Contract

This contract is entered into by and between the **College of Literature, Science, and the Arts Student Government (“First Party”)** and **Riya Gupta (“Second Party”)**. The terms of this Agreement shall begin immediately upon signing by both parties and continue through its termination occurring upon the final certification of the LSA Student Government Special Election results. Any terms of this contract that have already been completed shall not need to be re-completed.

The specific terms of this contract are as follows:

Riya Gupta - the Election Director must:

1. Create pre-approved Facebook posts prior to, and during the voting period encouraging individuals to vote in the elections.
2. Aid the External Relations and Communications Committee in advertising the election to the student body and encourage LSA students to vote in the election.
3. Set up and be responsible for managing the online voting system -- including posting the amendment and any Ballot Questions in the same Election tab on vote.umich.edu.
4. Tabulate and certify with the LSA SG Counsel the Election results.
5. Review complaints and issue demerits for violations.
6. Defend themselves and LSA SG, with the aid of the LSA SG Counsel, if a violation decision with election is brought to the Central Student Judiciary, except in the instance of a suit by LSA SG against the Election Director.
7. Formulate, and submit to the LSA SG Executive Board for review, an Election Director report.
8. Fulfill all other obligations of the Election Director set out in the LSA SG Bylaws or in the LSA SG Election Code.

In consideration of the mutual promises set forth herein, the First Party agrees that they shall pay the Second Party a sum of \$150 for the completion of their tasks.

The Second Party agrees that they shall only be paid if they properly complete items 1-8 as mentioned above.

This contract may not be modified in any manner unless in writing and signed by both Parties. This document and any attachments hereto constitute the entire agreement between the Parties. This contract shall be binding upon the Parties, their successors, heirs and assigns and shall be enforced under the laws of the United States, the State of Michigan, as well as the Constitution, Bylaws, and Election Code of the College of Literature, Science, and the Arts Student Government. This contract shall be null and void if no Special Election be called by the College of Literature, Science, and the Arts Student Government within sixty (60) days of its commencement, in such case, no compensation shall be disbursed to the Second Party.
