  - a. <u>Appointments Subcommittee</u> Claudia McLean (<u>mclaudia@umich.edu</u>)
    - I am sososo excited to see you all. I'm seeing Kayla for the first time tonight. Appointments is very busy, and the timeline has been mapped out. The application is open right now, and closes the 19th. We are making flyers for festifall. We are holding interviews from 13th-24th. - 1. List: What time do you think appointments hash is?
  - a. We don't have a specific time, but we can figure that out.

- b. <u>Health Subcommittee</u> Gaurie Gunasekaran (gaurie@umich.edu)
  - i. We really focused on mental, emotional, and physical health. We did care packages last year. This year we're focusing on private therapy covered for students. Many students have been negatively impacted by covid. We also want to work on student health insurance.
    - 1. Addison: Is there any therapy on campus?
      - a. We have CAPS! We also have created liaison positions
    - 2. Rifkin: What is the format of the therapy reimbursement process? Will it be a flat rate of reimbursement for each student?
      - a. We can only reimburse people for a small amount of money. We realize the money spent is not sustainable.
    - 3. Watt: We will continue care packages this semester?
      - a. We haven't thought about that, but we can work on it if need be.
- Judiciary Establishment and Election Code Amendment Task Force Max Stoneman (<u>maxstone@umich.edu</u>)
  - i. Very busy summer. I can't get into the details for the sake of your time. We have all our external forms together. I need everyone on board. It's a new branch of government. Sundays at 2:30. Please feel free to reach out. If we have a lot of people interested in being justices that's a really cool thing to have.
    - 1. Salino: Is there a timeline for when we will appoint justices?
      - a. Not yet, but we will get that started up soon.
    - 2. Watt: How many justices?

- d. LSA Annual Scholarship Task Force Vince Tedrick (vtedrick@umich.edu)

## c. <u>B F2021.14 Appointments Clarifications</u>

V.

- i. Watt: I'll have to update the take effect date. Remove the prohibition of having members in both CSG and LSA SG. This would remove the responsibility of the appointments to be "watchmen" over out appointees. 8.01.10 change the way appointed representatives are approved by the government. The entire government can now vote.
  - 1. Tedrick: Is CSG compliant with this?
    - a. Yes
  - 2. Burgaj: This amendment is similar to one in the past.
    - a. That one talked more about appointees within the government. This one talks more about positions being held in both governments.
  - 3. Tedrick: Under conduct of appointees change fails to fail.
    - a. Yes.
  - 4. Juliao: Change august 30th to september 1st.
    - a. That's friendly
- ii. Burgaj: Motion to table for two weeks.
  - 1. No second
- iii. Addison: Motion to vote by acclamation
  - 1. Second: Farah
  - 2. Aye's win passes
- 15. New Business
  - a. <u>Notice of Minor Bylaw Edits</u> (Watt)
    - *i.* These edits are considered to be adopted without need of motion, though the Government may vote to overturn them. See 1.01.11.
    - ii. Watt: These are automatically part of our bylaws. If you have no objections, we approve them and move on.
  - b. <u>B F2021.15 Prohibition of Unmentioned Powers</u>
    - i. Watt: Currently we can sneak in little hidden meanings and powers in resolutions and get it approved by exec and IRC. I would not like to see this be exercised.
      - 1. Tedrick: The wording confuses me. Could you explain this?



- a. It just makes sure were not being vague and giving ourselves power.
- 2. Burgaj: Wouldn't this make it so that we are given more unmentioned powers? Can you remove that limitation without replacing it? How will you go around this?
  - a. If there's no one to mention what unmentioned powers are happening. It hi TYLER FINISH THIS
- 3. Neff: Motion to table for two weeks
  - a. Watt: second
- c. <u>R F2021.07 Support for LEO</u>
  - i. Farah: LEO has very reasonable demands and the University isn't meeting them. They've been negotiating for eight months now, and there hasn't been any headway. The starting salary at Umich Flint and Dearborn isn't even a living wage in Michigan. If we pass this we will endorse their demands and support them if they decide to strike. I don't want a strike, but I don't want people to work under discriminatory policies. I would like to see this passed tonight. We will be standing in solidarity with one of the most important parts of our University.
    - 1. Tedrick: You just copy and pasted their points from their website?
      - a. It was a summary. Most is copy and pasted from CSG resolution.
    - 2. Salino: We don't need to suspend the rules to pass this?
      - a. No
    - 3. Slack: Are they advocating that the University take away the felony disclosure?
      - a. Yes
      - b. Slack: Including violent crimes as well?
      - c. Yes
      - d. Slack: If they're getting rid of this entirely, it may be harmful? Could they maybe change it?
      - e. You can reach out to them. Why should you be punished for the rest of your life.
    - 4. Neff: For Flint and Dearborn have their SG made any statements? Does this call for them to make similar statements?
      - a. Juliao: Flint has, we just had the DEI rally. Dearborn is also calling for this.
    - 5. Addison: I agree second chances are good, but maybe we need to be more specific about types of felonies? I don't know if people come and go with something like sexual assault? I would be hesitant to welcome this onto the campus.



- a. I understand the sentiment. I will point out the most violent crimes at the University have been those without past records. We had Dr. Anderson and he is not the only one. If you served your time you shouldn't be punished for it.
- 6. Burgaj: Does the sponsor realize he is comparing a median salary and a starting salary?
  - a. We're not doing that. We're comparing median salaries with other salaries.
    - i. Burgaj: It's the wording. I'd be happy to help you rewrite it.
    - ii. I disagree.
- 7. Stoneman: Do you believe it is essential that we vote on this tonight even if there are concerns? Does the sponsor feel comfortable working with this in the amendments section?
  - a. I don't think LEO will change their demand. Either we endorse their platform or we don't.
- 8. Neff: The presenter did say that they would like to see it passed tonight.
- 9. Burgaj: Were the bullet points copy and pasted from the website? The first bullet point can be seen as antagonizing.
  - a. It's from the original author. The person who wrote a lot of this resolution started talking early on with LEO about SG can help out.
- 10. Neff: Adding a section that we also stand in solidarity with the other student governments.
  - a. Farah: I'll see where that fits in.
- 11. Burgaj: Removing the aggressive line. Top bullet point, part 2.
  - a. I think what's happening right now is disrespectful. However I do understand where you're coming from. We can change the wording.
  - b. Burgaj: That part is not from LEO, that's from the author.
  - c. I'll propose an amendment.
- 12. Addison: If in the felony clause you can add excluding sexual assault. I fear a repeat offense on campus
  - a. That would not be a friendly amendment.
- ii. Addison: Add "excluding sexual assault" to the felony clause unfriendly amendment
  - 1. Watt: "with the exception of the blanket repeal of the Felony Disclosure policy"
    - a. Can you explain blanket repeal



- 2. We can't change their demands
- 3. Addison: that's acceptable
  - a. Watt: second
- 4. Watt: motion to open a speakers list on the amendment
  - a. Salino: seconde
    - i. Consent
- 5. Speakers List for amendment:
  - a. Addison for: I think this is very important in the long run. I do agree many felons are falsely represented as violent, I think they are great people. I do have preconceptions about past assaulters are great representation for the university.
  - b. Burgaj against: You either believe in second chances or you don't. We should not pass judgement. They've served their time, they are not felons.
  - c. Watt for: Being formally incarcerated does not mean there was a change in character. I want to support unions, but will this felony line that LEO has presented I don't know how willing I would be to support them.
  - d. Farah against: Boiling someone down to a "felon" is unacceptable. Many are falsely convicted, and this is far more common in POC. We want diverse lecturers on campus. If we make exceptions, we will not be accepting the change in policy that will help our university the most. I think the best way to combat SA is to have good oversight and good support mechanisms. This is a discriminatory policy.
  - e. Slack for: I am still including the blanket repeal. I don't know the Felony policy exactly. As the policy stands, would it be more helpful where those who apply for the university are given expungement help without removing the policy completely.
  - f. Vidhya-Ponraj against: I still do think that someone who serves their time does not deserve to be marked as a felon. Even with those who commit a sexual assault are placed on a sex offenders registry and I'm sure the unversity will see this
  - g. Neff against: We have to look at the data LEO has sent out, and I have personal experiences with this in my life. My foster brother, POC, was one of the nicest people and was on a great path. He was wrongly convicted of an armed assault. He now has a child, and he has had so many problems getting a job so he has trouble provide for his daughter. The burden is now on his wife. I



know we fear for our safety. The lives of them and their families are being put at risk. We need to put full support in for LEO. I came into this unsure, but now I think we need to be fully behind them.

- h. Kado against: Thank you everyone. I do have to say that. I understand where people are coming from and as a female on campus it can be concerning, but I think it's important that we do include felons. If we were to add this amendment we would be further disadvantaged by those already disadvantaged.
- i. POI Gunasekaran: Can we make a separate amendment for this clause? Vote on everything else today?
  - i. I think it's a bit complicated. We should see if this amendment passes or not.
- j. POI -Rich: The policy talks about all employees at the university? Is this for everyone or just LEO?
  - i. LEO can only bargain for lecturers. I don't think they can bargain for everyone.
- k. Rich: So this would still have a lasting impact for other groups?i. Would start a larger question.
- 1. Tedrick: Motion to vote by placard
  - i. Second: Watt
  - ii. Consent
