 - ii. Questions/Comments:
 - 1. (Ramos) Some kind of compromise for people who do want their AP credits to mean something to shorten their time at the Univ to save money and get through college faster. Does the process of giving them more advisors and whatnot be a separate bill?
 - a. (Torres) I would be more than happy to continue working on this discussion regarding what more can be done to help those who have been affected graduate in time. Come to AAC!

- k. Binding Ballot Question Proposal #1 (Torres, Goodsell)
 - i. Proposed language: For our presidential and vice presidential candidates, should a requirement to run be that they have been in LSA Student Government in some capacity for a minimum of one semester?

ii. Sponsor introduction: People must have been in LSA SG in some capacity in order to run for President/VP. I believe that what is best for smooth transitions is knowledge of the government's work. Regarding accessibility, this would limit the number of members able to run. There was judged to be no accessibility issue. This would limit the number of people eligible of run. As we discuss whether or not to put this on the ballot, we are asking whether students should have the ability of vote on this matter. Students should have the primary say on this matter.

iii. Questions:

- 1. (Walker) What does the phrase 'involvement in some capacity' mean, and why is it not in the language of the ballot question?
 - a. (Torres) I wanted to make it vague. There are many ways to be involved. Including being involved in a committee project
- 2. (Tedrick) Could its vagueness lead to not having a purpose?
 - a. (Torres) I don't want to restrict people for the sake of restricting people. There are many ways for this to apply. I would prefer to keep it as vague as possible.
- 3. (Stoneman) Does this mean the entirety of a semester, or only part of one? Like appointed and associate reps? Do separate iterations apply (being a member at two separate times0
 - a. (Torres) I feel like my interpretation would require involvement in some way, thus including appointed reps and associate reps.
 There would also be a conversation about the requirements and what they could be.
- 4. (Bazzi) Experience in the government is not all that it takes. It takes other traits of leaders. All student sra eassociated with us, as we collect student fees. You mentioned that we are trying. Are you aware that attending an LSA SG meeting is a requirement for running
 - a. I am aware of this. I understand this. We can agree to disagree about what makes a strong leader. If we were to propose something, I think it would be necessary to have student input.



- b. (Bazzi) It is not an agreed to disagree situation. I know what it takes.
- c. (Torres) people will have different opinions about what makes a good leader. There are different ways of judging this. I don't think that is necessary. I disagree with the argument as stated.
- 5. (Crews) I think it would benefit us regarding what the students feel. We could also ask what kind of leadership experience should count.
- 6. (Ramos) We are representing the people. Is it more important for the President to have government experience, or is it more important for them to understand how to represent the people?
 - a. (Torres) My goal is to get student opinions to decide the government's stance. Is this what students want? Are we actually doing what the students want?
- 7. (Goodsell) I feel strongly that students should have the ability to vote no. It is a question where there is no harm asking. It could benefit us and many other students.
- 8. (farah) I am concerned that a lot of students are not very informed about how LSA Sg runs. My question to the sponsors is that, do you think that bthe time spent after the march elections is enough time to become acquainted with the rules of the government?
 - a. (Torres) I feel that it depends. There is not that much experience you can possibly get. We don't have the same experiences during that time either.
- 9. (Walker) The sponsor stated that the question will not restrict access to the government. How is the student body supposed to know what is meant by 'some involvement' when that is not stated in the question? Further, who is the arbitrator of what the involvement looks like?
 - a. (torres) I attended DAC; they did not see this as an issue of inclusivity. The highest level of involvement should have requirements Regarding contradictory notions, I don't believe



- that it is contradictory. The idea of an arbiter would fall upon the Election Director.
- b. (Walker) The stance regards the wording; many interpretations can occur. It is too open ended (a very general question). Voters do not know the full scope of what involvement may constitute. How is the student body supposed to know what this means?
 - i. (Torres) I would consider it an unfriendly amendment if it was to be rephrased to be more specific.
- c. (Walker) would you be willing to clarify about what kind of experience ought to be needed?
 - i. (Torres) The Government can decide this.
- 10. (Cohen) I want to clarify the intentions. Is this to allow the student body to decide what best makes a leader?
 - a. (Torres) OI think that is what I was going for exactly
- 11. Watt: Would you considered adding context around the 2002 or 2004effort?
 - a. Toress: I want to say thank you to the Michigan Daily, as their reporting helped us find this data. There was a question brugoht up by government members about more political actions and not ideas. There was a ballot question that year that would make the president/VP be voted in by internal elections, rather than the student body election. I am not sure if this was a controversial motion, but I am going to look at the end of the year report. The Daily Report noted that the majority of representatives and Deans Office was in favor of it.
- 12. Could it be characterized that this was an internal effort to ensure that people from outside of the government did not gain power?
 - a. Torres: Yes
