15. Old Business

a. [B W2022.12 An Amendment to the Fifth Chapter of the Bylaws Restructuring the Special Provisions](#)

- i. Tam: The plan is to pass this today. Just confirmed our justices. This requires justices to work. This has been on the agenda for a couple months. Pending a small edit I've highlighted; I want this to pass.
- ii. Stoneman: There has been different conversations relating to this, but no one has made any substantive recommendations about this. There is really important stuff in here, I would hate to table them. I am open to friendly amendments. All of this is pretty heavy stuff. You've been able to read this a few times. If you have something, bring it up now, if not let's pass this.
- iii. Nighswonger: What is the process for Sg to send this to Sj
- iv. Tam: If somebody has committed something against the code of conduct, we send out a code of impeachment and it gets passed by $\frac{2}{3}$ vote.
- v. Nighswonger: Just to clarify we would be voting on whether or not this goes to SJ
- vi. Stoneman: We've been working on how the impeachment process is going to work in SJ.
- vii. Tedrick: Why shouldn't all SJ's be present? We only have 5 shouldn't it be all.
- viii. Stoneman: Ideally it would be all. More times than not everyone will be there. In the off chance only 3 are there, that is something that is on the table.
- ix. Watt: This will not restrict the rights...
- x. Nighswonger: If there is an even number of justices and there is a split vote what happens?
- xi. Stoneman: This will likely not happen. I trust them to make the right call.
- xii. Ella: I know the justices we've appointed now would not put themselves in that sitch; should we add a provision that if only 4 are able to be present we should reschedule?
- xiii. Tam: You need a $\frac{2}{3}$ majority to impeach, if there isn't a $\frac{2}{3}$ then you can't impeach.
- xiv. Cohen: The opportunity in which there would be 4 justices is unavoidable, it is incumbent on the government to decide how to break a tie, but this would not be in our documents.
- xv. Ella: Hopefully impeachment won't be common; can't we just say all 5 must be present?

- xvi. Cohen: There may be situations where there literally cannot be 5 justices. The more common concern is about recusal not scheduling.
 - xvii. Nighswonger: General comment: this conversation is not a reflection of the quality of the document, this is just happening because we're watching the creation of a new branch.
 - xviii. Ella: Do we have a solution for if there's only 4 justices present?
 - xix. Stoneman: That is not a situation we planned for because it's not a situation we can anticipate. I don't want to tell the justices how to do their job; but I trust these people to make the right decision because they were appointed by the government. It's not gonna be a common thing
 - xx. Cohen: This is an important concern. It would be reasonable to construct an amendment to the manual procedures that they have a defined system for what happens in the case of a tie. There are solutions we can look at for this; we can look at them and make a decision ASAP. Post this document.
 - xxi. Watt: It is my understanding that if the judges tie then the status quo is what stands (a majority vote). Is that accurate?
 - xxii. Stoneman & Tam: Yes.
 - xxiii. Stoneman: There is always an avenue for appeals in LSA SJ.

- i. Farah: I was in the union and I saw Rico restocking the vending machine which contains products meant for students of color. Without this vending machines students will have to go to other cities to get these hygiene products. I'll let Rico explain.
 - ii. Rico: Thanks for letting me be here. This initiative started in 2020. As students of color you can go weeks or months without having a hair conditioner or shampoo that doesn't break your hair or dry it out. These are small things that let you feel comfortable in your own skin. Without these products students can feel nervous and uncomfortable. At this university we have to know how to sell ourselves in 30 seconds, without confidence we can't do this. So we came up with an idea to put products for students of color in the union. We received a grant to put the machine in the union. We just are asking for funding to restock the machine. These products are expensive and we'd appreciate financial support. SG has a big reach. I appreciate you.
 - iii. Nighswonger (question): Where did your original grant come from?
 - iv. Rico: Optimize

 - vi. Rico: I plan to be here as long as I can. There are a few orgs on campus who are interested in this.
