*Suárez's Metaphysics: Transcendental and Analogical*: In progress, a monograph that considers central aspects of the scholastic metaphysical system of the Spanish Jesuit Francisco Suárez (1548–1617), who was lauded during the seventeenth century as “Prince and Pope of all Metaphysicians” (*omnium Metaphysicorum Principis ac Papae*). This study focuses primarily on Suárez’s seminal text, *Disputationes metaphysicae* (1597), which develops a “transcendental” science of metaphysics that has as its principal object “being insofar as it is real being” (*ens in quantum ens reale*). Suárez’s version of this science attempts to mediate various competing “realist” and “nominalist” accounts of the nature of this object. In addition to offering this sort of transcendental metaphysics, Suárez addresses the foundational debate within scholasticism over whether the concept of being applies to objects in a “univocal” or merely “analogical” manner. With respect to this debate, Suárez once again proposes a middle way, one which highlights a form of analogy that takes on board certain univocalist views that are required for his transcendental metaphysics. In addition, Suárez’s analogical metaphysics includes an attempt to reconcile a traditional Aristotelian theory of the ten “categories” of being (namely, substance and nine kinds of accident) with the highly original and influential account in his transcendental metaphysics of the fundamental distinction between a “thing” (*res*) and its “mode” (*modus*). Suárez’s metaphysics is examined throughout in the context of the relevant medieval and early modern scholastic debates with which he engaged, and it is related to a critical assessment of the recent claim of one commentator that his system “constitutes the inflection point between the Middle Ages and Modernity” (*constituye el punto de inflexión entre la Edad Media y la Modernidad*).
