# Sexual Violence in Armed Conflict (SVAC) dataset (with Dara Kay Cohen and Rob Nagel)

Winner of the J. David Singer Award for Data Innovation (2023)

The Sexual Violence in Armed Conflict (SVAC) dataset measures reports of the conflict-related sexual violence committed by armed actors during the years 1989-2021. The armed actors include government forces, pro-government militias, and rebel groups between 1989-2009 (SVAC 1.0), and government forces and rebel groups for 2010-2015 (SVAC 2.1) and 2016-2021 (SVAC 3.2). The dataset includes information about the prevalence, perpetrators and forms of the reported sexual violence by each armed actor in each conflict-year. The information used to compile these data comes from three sources: the U.S. State Department, Amnesty International and Human Rights Watch. <a href="http://www.sexualviolencedata.org">http://www.sexualviolencedata.org</a>

#### Book manuscript: Capitalizing on Shame -- Why states commit sexual violence inside and outside war

This is the first major work to brings our attention to how states commit acts of sexual violence not only as part of warfare, but also as part of their repressive repertoire. The book develops existing explanations and presents a new theoretical framework for explaining variation in sexual violence by state actors. The analysis in the book draws on new data on patterns of sexual violence by states in the years 1980-2016, and survey experiments assessing how people understand the strategic utility and impact of sexual violence as a form of political violence and repression.

#### **BIO STATEMENT**

Ragnhild Nordås (Nordaas) is an Assistant Professor of political science at the University of Michigan studying the causes, dynamics, and consequences of political conflict and violence --particularly civil war and state repression. In recent years, her work has centered on conflict-related sexual violence. She is the co-Director of the Sexual Violence in Armed Conflict (SVAC) data which is the recipient of the J. David Singer Award for Data Innovation. She has published 24 peer-reviewed journal articles, 7 book chapters, and a series of policy briefs and reports. Her work has appeared in leading academic journals, including i.a. the American Journal of Political Science, Annual Review of Political Science, Journal of Conflict Resolution, International Studies Quarterly, and Journal of Peace Research, generating more than 3,400 citations in Google Scholar. In addition to scholarly impact, Dr. Nordås also communicates research findings to a wider audience and consults with policy makers and practitioners such as the US State Department, the United Nations, the Norwegian Ministry of Foreign affairs, Save the Children, and USAID. Her current book project seeks to understand variation in sexual violence by state actors inside and outside war.
